**RESOLUTION APPROVING CLERK/AUDITOR'S WRITTEN FINDINGS TO
WITHDRAW CERTAIN PROPERTY FROM THE 2020 TAX SALE**

WHEREAS, the Utah County Clerk/Auditor may, pursuant to Section 59-2-1350, issue a written finding that it may be in the best interest of the public to withdraw a property from the tax sale;

WHEREAS, the Utah County Clerk/Auditor may withdraw the properties identified in the written finding from the tax sale if the Board of County Commissioners of Utah County approves the written finding;

NOW, THEREFORE, be it resolved that the Board of County Commissioners of Utah County, Utah, hereby approves the written finding that it may be in the best interest of the public to withdraw the properties listed in the Utah County Clerk/Auditor's written finding, which list is attached to this resolution. Be it also resolved that the Utah County Clerk/Auditor may now withdraw the properties listed in the Utah County Clerk/Auditor's written finding from the 2020 tax auction.
