### **Community Service Guidelines and Requirements**

When you are granted the privilege of Community Service in lieu of a fine or jail you are responsible to arrange to complete your assigned hours and return the documentation to the Court within the specified time period. If you fail to complete the Community Service hours or if you fail to return the documentation to the Court within the specified time period you will lose the opportunity of Community Service.

Community Service hours have to be <u>supervised</u> and <u>documented</u> hours with a <u>Non-Profit</u>

<u>Agency</u> that has an active Court appointed Community Service Program. The agency that allows you to work the Community Service hours must provide someone to supervise the Community Service

Work. A person that you are related too can NOT supervise your Community Service. The

Community Service agency must keep records of the hours worked and record the hours worked on the Community Service Order that is provided by the Court. The person that supervises the

Community Service Hours must sign the Community Service Order that is provided by the Court once the Community Service Hours have been completed.

The Court reserves the right to determine what Community Service providers are qualified, so if you have a question contact the Court.

Examples of providers that are NOT acceptable; Helping a family member or the neighbor next door will NOT be considered qualifying Community Service by the Court. Coaching a Little League baseball team is NOT qualifying Community Service. Working for a company that you are directly or indirectly associated with, is NOT acceptable Community Service. Working at a privately owned Nursing Home is NOT acceptable Community Service. Correcting papers for a school teacher is NOT acceptable Community Service.

**NOTE:** You can NOT count Community Service hours worked for another case or court. Community Service Hours must be for this case only. Also, Donated Goods can NOT be converted into hours. Community Service Hours must be WORKED.
