Brian Thompson began the Tax Sale at 10:04 A.M. by welcoming all present. He explained the how the Tax Sale would proceed. He went over each item listed on the Bidder Registration form that all bidders signed as part of the registration process. He explained some properties may have been removed from the sale due to proper notice was not given, erroneous legal descriptions, bankruptcy, deferrals, or settlements had been granted on the property.

Mr. Thompson announced the serial numbers that had been redeemed or pulled from the sale. Then, he announced each serial number and called out bids on each property. At the end of bidding on each property, he announced the winning bid and bidder number.

At 11:00 A.M., Mr. Thompson announced the bidding was closed. He explained all winning bids would have to be paid to the Utah County Treasurer's Office within the next two hours by cash or cashier's check. He explained all bids not paid for by would be re-bid again in the afternoon session. The Tax Sale then adjourned until 1:00 P.M.

At 1:00 P.M., Bryan Thompson explained there were 2 properties that the winning bid had not been paid. He announced the bidding was open for these 2 serial numbers. Each serial number was then rebid. Finally, Mr. Thompson read a statement that the properties that had not been bid on were subsequently were struck from the sale.

The meeting then ended at 1:05 P.M.
