Bryan Thompson, Utah County Clerk/Auditor began the 2018 Utah County Property Tax Sale at 10:04 a.m. and welcomed those present. He introduced the Utah County staff and explained how the Tax Sale would proceed. He went over the Bidder Registration form that all bidders were required to sign as part of the registration process. He explained some properties may have been removed from the sale due to property notice was not given, erroneous legal descriptions, bankruptcy, deferrals, or settlements had been granted on the property. He also explained that some of the parcels are only available for Preferred Bidders and the rest are Bid-Up (sold to the highest bidder) or Undivided Interest. He also explained that if no bid was received, the unsold properties would be struck from the sale and become the property of Utah County.

Bryan Thompson announced any serial numbers that had been redeemed or pulled from the sale that were printed on the Tax Sale List of Delinquent Parcels. Then, he announced each serial number, starting bid amount and called out each subsequent bid on each property. At the end of bidding on each property, he announced the winning bid amount and bidder number.

At 10:58 a.m., after the last serial number had been bid on, Bryan Thompson announced the bidding was closed. He explained all winning bids would have to be paid to the Utah County Treasurer's Office by 12:00 P.M. by cash, certified check, or money order. He explained bids not paid for would be re-bid again in the afternoon session that would start at 12:00 p.m.

The 2018 Utah County Property Tax Sale adjourned until 12:00 p.m.

At 12:00 p.m., Bryan Thompson explained there was one property that the winning bid had not been paid. He announced the bidding was open for this serial number. It was then re-bid. After this serial number had been bid on, Bryan Thompson announced the bidding was closed.

The 2018 Utah County Property Tax Sale ended at 12:05 p.m.
