Josh Daniels, Chief Deputy Clerk/Auditor began the 2019 Utah County Property Tax Sale at 10:06 a.m. and welcomed those present. He introduced the Utah County staff and explained how the Tax Sale would proceed. He explained that some of the parcels are only available for Preferred Bidders and the rest are Bid-Up (sold to the highest bidder).

Josh Daniels announced each serial number, starting bid amount and called out each subsequent bid on each property. At the end of bidding on each property, he announced the winning bid amount and bidder number.

At 12:46 p.m., after the last serial number had been bid on, Josh Daniels announced the bidding was closed. He explained all winning bids would have to be paid to the Utah County Treasurer's Office by 2:00 P.M. by cash, certified check, or money order. He explained bids not paid for would be re-bid again in the afternoon session that would start at 2:00 p.m.

The 2019 Utah County Property Tax Sale adjourned until 2:00 p.m.

At 2:24 p.m., Josh Daniels explained that all properties that had had been sold in the first round of bidding had been paid. He announced bidding was now open for all unsold serial numbers from the earlier session. After the last serial number, Josh Daniels announced the bidding was closed. He explained that if no bid was received, the unsold properties were struck from the sale and became the property of Utah County.

The 2019 Utah County Property Tax Sale ended at 2:42 p.m.
